Greetings from the children, senior citizens, staff and trustees of Sevalaya.

Sevalaya's Mahakavi Bharathiyar Higher Secondary School has achieved 98 % result in the X Std Public Examination. Out of 53 students, 52 have been successful. The top scorer of the school is **K.Sangeetha** with 459 Marks (92%). **U.Ganapathy Ram** came second with 455 (91%) and **M.Kanaka** scored 451 (90%) to secure third position. 14 students have scored above 400.

The achievement is significant as these students come from economically backward families and most of them are first generation learners. **K.Sangeetha** the school topper's father is an agricultural coolie, **U.Ganapathy Ram** lost his father at a young age and his mother works as a house keeper labour. He is under the care of Sevalaya since Balwadi and is a resident of the Sevalaya Children's Home. **M.Kanaka's** parents work for daily wages.

We gratefully recall once again the trust you have reposed in Sevalaya by your generous contribution and the dedication of our staff members at this juncture. We are happy that your confidence in us has been fully justified and your noble gesture has made a difference in so many children's lives.

Well, the next academic year is to start very soon. While the average annual expenses of education per student for a year is Rs.6000, we immediately need to muster at least Rs.1000 for each student for initial expenses for the year, like uniforms, stationery. To whom else shall we turn for support except people like your bening self?.

It is heartening that our earlier appeal has elicited generous response. However, we would like to bring to your attention the enormity and the urgency of the task. Kindly lend as much help as early as possible and send your remittance at the earliest, as it is desirable that all the children are fully equipped with their needs from day 1 of the academic year.
